- 1. To accomplish the aforesaid purposes and in mutual consideration of the obligations entered into under this contract, it is hereby agreed and between the said Client and DJ TonyT's Mobile DJ Service as follows.
2. DJ TonyT's Mobile DJ Service agrees to provide to the Client for compensation certain entertainment services, which may include sound and light shows, background music and live entertainment, and to provide a master of ceremonies to coordinate this event.
3. DJ TonyT's Mobile DJ Service in lieu of such emergency situations, vehicle accident, vehicle breakdown, serious illness, life-threatening situation and/or in the case of a natural disaster that hampers delays and/or halts DJ for Event may not exceed liability of said services of total amount owed for Event. However, there may be a full refund and/or discount on any monies owed for Event. In such case as well DJ TonyT's Mobile DJ Service may be forced to alternate and/or change qualified DJ's for such Event.
4. DJ TonyT's Mobile DJ Service may not be held responsible for any previously and/or current insufficient, misused and/or damaged power supply, any equipment and/or electrical source that is provided to power DJ equipment at location of this Event, and in the event of a power failure and/or power outage that is not the fault of the DJ and/or DJ equipment at Event which DJ services is in effect a minimal charge rounded to the nearest hour of each hour performed, divided by total amount due of said services for this Event may be charged.
5. The Client, in consideration for these services, agrees to pay to DJ TonyT's Mobile DJ Service the deposit with the return of this agreement and the balance on the date of the event, unless otherwise specified & agreed upon prior to event. Fees for extended service outside the hours here unto agreed upon in this contract, requested by the Client shall be due on the date of the engagement.
Balance due in full if event is cancelled inside of 90 days of event date.

- 6. Shall Client breach the terms of this agreement in any way, the Client agrees that DJ TonyT's Mobile DJ Service will retain the total amount of the deposit as liquidated damages and is not a penalty. DJ TonyT's Mobile DJ Service, DJ's, at their discretion, reserve the right to make announcements and take photographs that may be conducive to the event.
7. DJ TonyT's Mobile DJ Service agrees that either its owners or employees are authorized by the terms of this agreement to collect the remaining balance owed to DJ TonyT's Mobile DJ Service to execute the terms of the agreement.
8. METHOD OF PAYMENT: CHECK, CASHIERS CHECK, MONEY ORDER AND/OR CASH IN PERSON.
9. Please make all correspondence payable to Tony Taylor. Note: Any out of state checks must be paid in full 7 days prior to date of event.
10. The Client agrees to pay DJ TonyT's Mobile DJ Service the balance due on or before date said services are to be provided to Client by DJ TonyT's Mobile DJ Service. Should the Client fail to do so, Client agrees to pay reasonable attorney fees, a \$50.00 late fee plus the maximum allowable interest under applicable law on the final balance due and all other costs and expenses incurred including reasonable attorney fees for the recovery of said amount.
